What is customs duty on solar panels?

According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

How to import photovoltaic panels?

If you want to import photovoltaic panels, you should have at least basic parameters of the goods specified. Based on your requirements, the supplier will be able to suggest you the most suitable product. The country that ranked first in the production of photovoltaic panels in the world is China.

How much does it cost to import goods into Jamaica?

Total Cost = \$1,000 (CIF) + \$200 (Import Duty) + \$3 (SCF) + \$5 (Environmental Levy) + \$180.45 (GCT) + \$2,500 (CAF) = \$3,888.45
