Are solar panels a viable option?

However, some states still make installing solar panels functionally impossible by creating laws with “reasonable restrictions,” such as increased taxing, energy caps, or even billing solar panel users. Combine these laws with a lack of incentive programs, and solar panels are not viable for homeowners in many states.

Do ordinances restrict PV solar deployment?

Our findings show that, in contrast with ordinances restricting wind deployment, there are few ordinances that are substantially inhibiting to the deployment of new PV solar. This is likely because ordinances governing setback are often intended to minimize noise or avoid structures interfering with sightlines and landscapes.
