The Zaragoza plant of global automotive giant Stellantis is partnering with CATL, the world's largest EV battery manufacturer, to expand electric vehicle production and build a large-scale battery manufacturing facility in Spain.

CATL's upcoming battery plant in Spain will be an add-on to its existing facilities in Germany and Hungary. These operations have made CATL a global leader in battery innovation, with the company consistently topping in EV battery usage and energy storage shipments worldwide.

They said the plant will be located in Zaragoza and start producing lithium iron phosphate batteries by the end of 2026.
